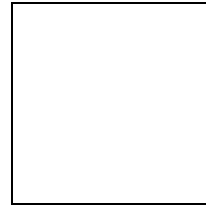

1. Before anyone is due for 3.5% interest loan, such member must have at least contributed for period of six months in which it is a must that the member contributes in each week of the month up till six months (6 MONTHS). Note monthly package is also allowed.
2. The association is open for anybody interested as long as “the person is of legal age and sound mind” bellow age years is open personal savings account.
3. Two guarantors requiring or one affidavit plus one guarantor inside members or stake holder.
4. Any person or member requesting for LOAN, can only get it times two of his PRINCIPAL (*2).
5. Such guarantor must be legal age and have business or civil servant with valid identity card.
6. Repayment period is 6 month & 8 months and it could be repaid weekly or monthly as well.
7. Two percent interest for members who contributes for the period of six (6) months.
8. There is a sign up for Next of kin for member in case of DEATH.
9. Any member requesting for TERMINATION OF MEMEBERSHIP must give (3) three months’ notice, or and such member can suspend the account instead of TERMINATION of account.
10. Service charges is at 3.5 % on free interest loan from #20,000 and above.
11. There shall be 10% FLAT charge for non interest loan payable within max of 6months, 5% charge within 2months.
12. There shall be review of rules from time to time as agreed by members so far such is conforming to the prevailing rules and regulations.
13. Minute shall be fixed for a tune of fifty naira for now (50) weekly or (200) once in a month.
14. There shall be dividend distribution yearly in proportion to individual contribution to date.
15. There shall be monthly maintenance fee of two hundred naira only (N100).
16. Request form shall be fixed for 500 and 1000 depending on amount request.
